We have acted as English legal advisers to Orchard Therapeutics plc, a public limited company incorporated in England and Wales (the "Company") in connection with the preparation and filing of the registration statement on Form S-8 to which this letter is attached as an exhibit (such registration statement, including the documents incorporated by reference therein, the "Registration Statement") filed with the U.S. Securities and Exchange Commission (the "SEC") pursuant to the U.S. Securities Act of 1933, as amended (the "Securities Act"). For the purposes of this letter, the ordinary shares in the capital of the Company each having a nominal value of £0.10 are referred to as "Ordinary Shares".

As set out in the Registration Statement, it is proposed that an aggregate of up to 15,241,143 Ordinary Shares (the "Shares") will be allotted and issued upon the exercise or settlement of equity awards granted under (i) the Orchard Rx Limited 2016 Employee Share Option Plan with Non-Employee Sub-Plan and US Sub-Plan, as adopted by the board of directors of the Company (the "Board") on 18 October 2018 and approved by the Company's shareholders on 25 October 2018 (the "2016 Employee Share Option Plan"), (ii) the Orchard Therapeutics plc 2018 Employee Share Purchase Plan, adopted by the Board on 25 September 2018 and approved by the Company's shareholders on 25 October 2018 (the "2018 Employee Share Purchase Plan") and (iii) the Orchard Therapeutics plc 2018 Share Option and Incentive Plan, adopted by the Board on 25 September 2018 and approved by the Company's shareholders on 25 October 2018 (the "2018 Share Option and Incentive Plan" and collectively with the 2016 Employee Share Option Plan and the 2018 Employee Share Purchase Plan, the "Plans" and each, a "Plan").

We understand that the existing issued Ordinary Shares are not, and are not intended to be, admitted to trading on any market or exchange, or otherwise listed, in the United Kingdom.

## 1. INTRODUCTION

# 1.1 Purpose

In connection with the preparation and filing of a registration statement on Form S-8, we have been asked to provide opinions on certain matters, as set out below. We have taken instruction in this regard solely from the Company.

Goodwin Procter (UK) LLP is a limited liability partnership registered in England and Wales with registered number OC362294. Its registered office is at 100 Cheapside, London, EC2V 6DY. - (b) headings are for ease of reference only and shall not affect interpretation.

For the purpose of issuing this letter, we have examined such questions of law as we have considered appropriate to give the opinions set forth in this letter. We have reviewed such documents and conducted such enquiries and searches as we have considered appropriate to give the opinions set forth in this letter, including the following documents and the following enquiries and searches:

- (a) an online search at Companies House in respect of information available for inspection on the Company's file conducted on 30 October 2018 at 10.30 a.m. (London time);
- (b) an enquiry of the Central Index of Winding Up Petitions, London on 30 October 2018 at 10.30 a.m. (London time) ((a) and (b) together, the "Searches");
- (c) a PDF copy of the minutes of the meeting of the Board held on 25 September 2018 at which it was resolved, *inter alia*, to approve the 2018 Employee Share Purchase Plan and the 2018 Share Option and Incentive Plan;
- (d) a PDF copy of the written resolutions passed by the Board on 18 October 2018 approving, *inter alia*, the 2016 Employee Share Option Plan;
- (e) a PDF executed copy of the written resolutions passed by the shareholders of the Company on 25 October 2018 approving, *inter alia*, the Plans (together, the "**Written Resolutions**");
- (f) PDF copies of the Plans;
- (g) a PDF copy of the current articles of association of the Company dated 29 October 2018 (the "Articles"), the certificate of incorporation of the Company dated 1 August 2018 and the certificate of incorporation on re-registration of the Company as a public limited company dated 29 October 2018; and
- (h) a PDF copy of the Registration Statement.

# 1.4 Applicable law

This letter, the opinions given in it, and any non-contractual obligations arising out of or in connection with this letter and/or the opinions given in it, are governed by, and to be construed in accordance with, English law and relate only to English law as applied by the English courts, including the laws of the European Union to the extent having the force of law in England, as at today's date. In particular:

 (a) we have not investigated the laws of any country other than England and we assume that no foreign law affects any of the opinions stated below;



- (b) we do not undertake or accept any obligation to update this letter and/or the opinions given in it to reflect subsequent changes in English law or factual matters; and
- (c) we express no opinion in this letter on the laws of any jurisdiction other than England. It is assumed that no foreign law which may apply to the matters contemplated by the Registration Statement, the Company, any document or any other matter contemplated by any document would or might affect this letter and/or the opinions given in it.

# 1.5 Assumptions and reservations

The opinions given in this letter are given on the basis of each of the assumptions set out in schedule 1 (*Assumptions*) to this letter and are subject to each of the reservations set out in schedule 2 (*Reservations*) to this letter. The opinions given in this letter are strictly limited to the matters stated in paragraph 2 (*Opinions*) below and do not extend, and should not be read as extending, by implication or otherwise, to any other matters.

## 2. OPINION

Subject to paragraph 1 (Introduction) and the other matters set out in this letter and its schedules, and subject further to the following:

- (a) the Registration Statement becoming effective under the Securities Act;
- (b) the delegation of authority to the compensation committee of the Board (the "Compensation Committee") having been validly effected (*inter alia*, in accordance with the Articles, the Companies Act 2006 (the "Companies Act") and the Plans);
- (c) the Board and the shareholders of the Company having validly approved the Plans;
- (d) the Board or the Compensation Committee having validly granted the awards in respect of the Shares under the Plans;
- (e) the Board or the Compensation Committee having validly resolved to allot and issue the Shares, or grant rights to subscribe for the Shares, at duly convened and quorate meetings of the Board or the Compensation Committee or by way of duly passed written resolutions of the Board or the Compensation Committee in compliance with all applicable laws and regulations, and such resolutions being in full force and effect and not having been rescinded or amended;
